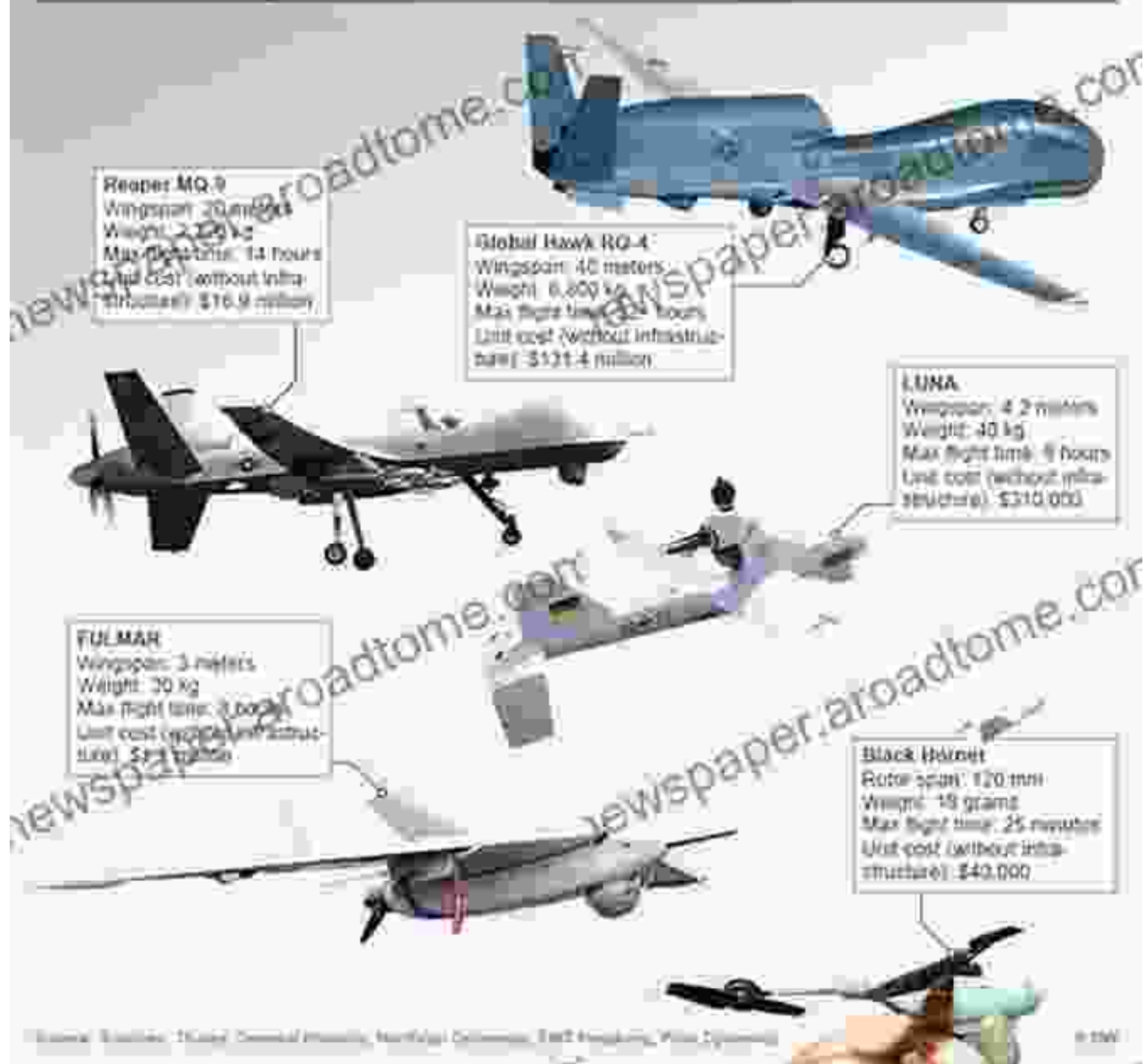

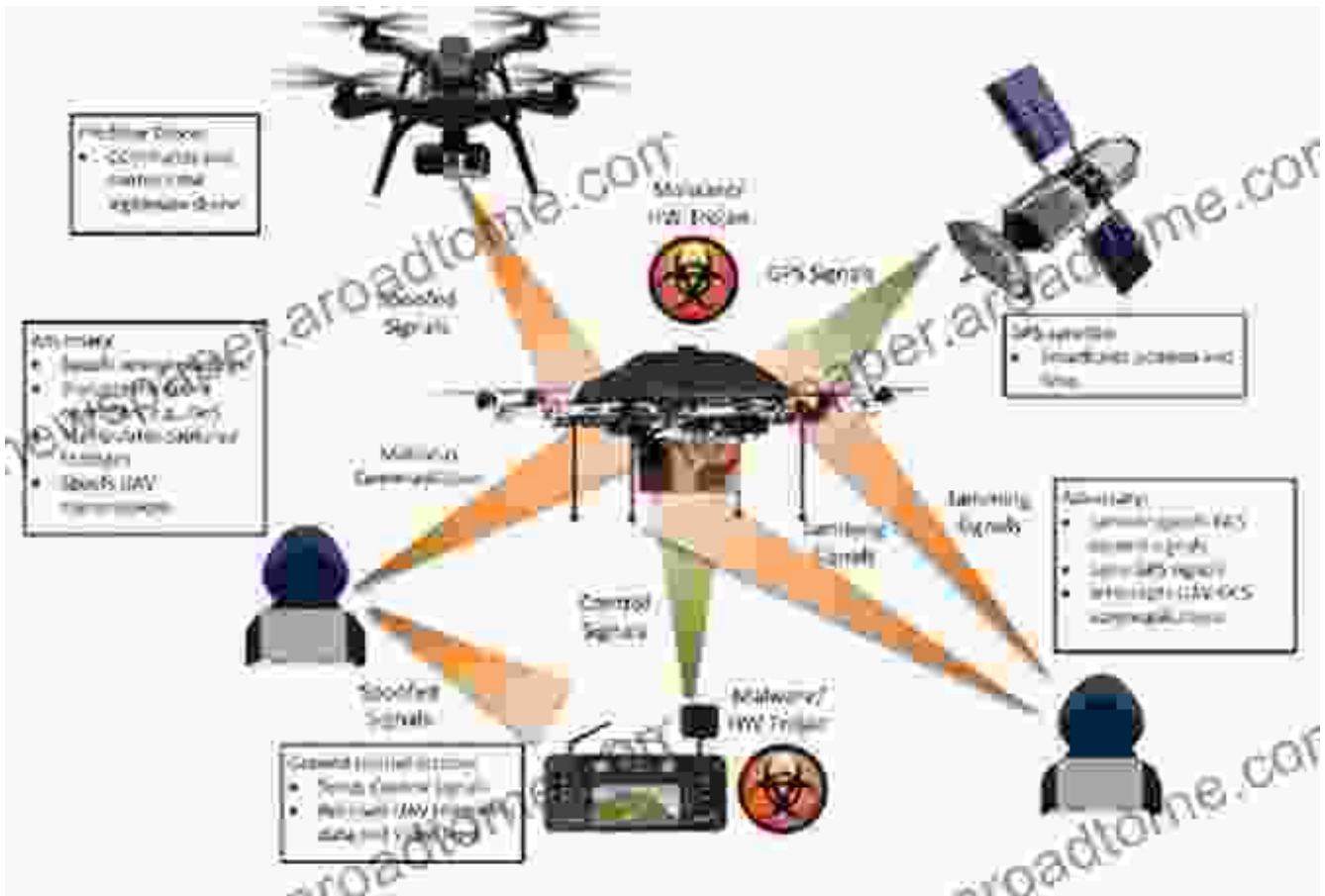


Figure 2: Drone Privacy and Data Protection

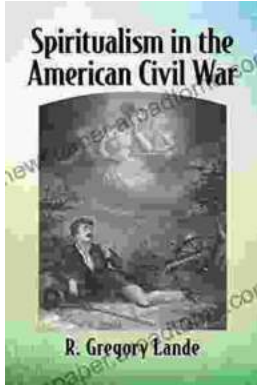
